ADDITIONAL FREE TRIAL TERMS FOR OKTA WORKFORCE IDENTITY CLOUD FREE TRIAL

These Additional Free Trial Terms for the Okta Workforce Identity Cloud Free Trial apply to the Okta Workforce Identity Cloud Free Trial available at okta.com/free-trials and supplement the applicable Free Trial terms in Okta's Master Subscription Agreement at www.okta.com/agreements (the "Agreement"). All capitalized terms not defined herein shall have the meaning set forth in the Agreement.

1. **Okta Workforce Identity Cloud Free Trial.** The Okta Workforce Identity Cloud Free Trial includes the Free Trial and Free Plan (as set forth below) and is made available for Customer to use, at its option, at no additional charge. The Okta Workforce Identity Cloud Free Trial allows up to ten (10) users per Customer to access and use the Free Trial and Free Plan.
 - a. **Free Trial.** The Free Trial grants to Customer the right to access and use the following generally available Okta Workforce Identity Cloud products: Single Sign-on, Universal Directory, Adaptive Multi-Factor Authentication ("AMFA"), Lifecycle Management, API Access Management, Device Access, and Workflows (limited to five active flows with a maximum of 1,000 executions per Customer) for a period of thirty (30) days (the "Free Trial Period").
 - b. **Free Plan.** After the Free Trial period, Customer will automatically convert to the Free Plan which grants Customer the right to access and use the following Okta Workforce Identity Cloud products: Single Sign-On, Universal Directory, AMFA, API Access Management, and Workflows (limited to five active flows with a maximum of 1,000 executions per Customer). Lifecycle Management and Device Access are not part of the Free Plan.
2. **Security.** The Okta Workforce Identity Cloud Free Trial will employ the same security measures as those present in the generally-available products and services subscribed to by Okta customers under an order form provided to the customers for their purchase of Okta products and services.
3. **Support Services.** The Okta Workforce Identity Cloud Free Trial is provided "as-is". Okta will not provide any Support Services for the Okta Workforce Identity Cloud Free Trial.
4. **Term and Termination.** The Okta Workforce Identity Cloud Free Trial period starts automatically when Customer submits the Okta Workforce Identity Cloud Free Trial sign up form and ends at the earlier to occur of (i) termination of the Agreement in accordance with the terms of Section 11 of the Agreement; (ii) upon Okta terminating the Okta Workforce Identity Cloud Free Trial due to forty-five (45) days of inactivity by Customer; or (iii) termination of the Free Trial service in accordance with the terms of Section 12.9 of the Agreement. Upon termination of the Agreement or the Workforce Identity Cloud Free Trial Service hereunder, your right to access or use the Okta Workforce Identity Cloud Free Trial and Okta products will terminate.
5. **Public Sector Customers (federal, state, local, tribal, territorial, Federally Funded Research and Development Centers (FFRDCs) or lab entities and certain educational institutions).** The Okta Workforce Identity Cloud Free Trial is not available to Public Sector Customers.
